Call for articles for the Special Issue

The Balkans in a Comparative Perspective: Recent and Emerging Trends, Innovative Narratives, New Theoretical Approaches

Rationale:

More than 15 years ago (2007) SEEU published the special issue 'The Balkans in a comparative perspective'. The articles discussed the leaders and laggers of post-communist paths to democratization, identity politics, nationalism and democracy, myth/s of ethnic wars, regional cooperation, EU values, etc. The SI happened to be a great success.

The ambition of the new special issue is to revisit both the region and its theorization, to identify and analyse new developments and emerging trends, from one side, insightful perspectives, new concepts, approaches, narratives, theories, explanations, from another side. The second ambition of the SI is to become a referential reading for scholars, politicians, stakeholders.

The contributions are expected to follow one or more of the enumerated axes:

- *Political* democratization v post-democracy, new political parties, emergence of new elites, risks/challenges, crises, national populism, electoral authoritarianism, diaspora engagement, etc.
- *Green and digital transitions* gig economy, digitalization, environmental policies and practices, etc.
- *Socio-Economic* (dis)balances of the economic liberalization; new entrepreneurs, old and new inequalities; corruption/state capture, etc.
- *Cultural* symbolic politics, politics of memory, art and politics, reconciliation, rewriting history in public places and debates, etc.
- *Civic* green, climate, environmental, eco, 'Occupy' and other forms of civic activism; contestatory and solidary citizenship, new forms of mobilizations on- and off-line; etc.
- *Diversity management* minority-majority relations, ethno-religious issues/tensions/conflicts; human rights.
- *Geopolitical* Europeanization, the impact and competition of great powers, etc.

The list is indicative. Other topics are welcome.

The **Journal Southeastern Europe** is abstracted/indexed in Web of Science, Scopus and several other data bases. It was rewarded the highest listing, A, by Italy's Research Quality Committee, Valutazione della Qualitat della Ricerca.
